PERMIT TO USE AN EXISTING WELL

ISSUANCE OF THIS PERMIT DOES NOT CONFER A WATER RIGHT CONDITIONS OF APPROVAL

- This well shall be used in such a way as to cause no material injury to existing water rights. The issuance of this permit does not assure the applicant that no injury will occur to another vested water right or preclude another owner of a vested water right from seeking relief in a civil court action.
- The construction of this well shall be in compliance with the Water Well Construction Rules 2 CCR 402-2, unless approval of a variance has been granted by the State Board of Examiners of Water Well Construction and Pump Installation Contractors in accordance with Rule 18.
- 3) Approved pursuant to CRS 37-90-137(2) to change/expand the use of an existing well operating under permit no. 301813, on the condition that this well is operated in accordance with the Merle Shrock Augmentation Plan approved by the Division 4 Water Court in case no. 18CW3045. If this well is not operated in accordance with the terms of said decree, it will be subject to administration including orders to cease diverting water. This well is known as the Shrock Well.
- The issuance of this permit hereby cancels permit no. 301813.
- The use of ground water from this well is limited to commercial and stock watering uses.
- The maximum pumping rate of this well shall not exceed 15 GPM.
- 7) The annual withdrawal of ground water from this well shall not exceed 2.38 acre-feet during Phase 1, and 3.57 acre-feet during Phase 2, as decreed.
- 8) The owner shall mark the well in a conspicuous place with well permit number(s), name of the aquifer, and court case number (s) as appropriate. The owner shall take necessary means and precautions to preserve these markings.
- 9) A totalizing flow meter must be installed on this well and maintained in good working order. Permanent records of all diversions must be maintained by the well owner (recorded at least annually) and submitted to the Division Engineer upon request.
- 10) This well shall be located not more than 200 feet from the location specified on this permit and decreed in Division 4 Water Court case no. 18CW3045, and at least 600 feet from any existing well, completed in the same aquifer, that is not owned by the applicant.

NOTE: This permit will expire on the expiration date unless a pump is installed by that date. A Pump Installation and Production Equipment Test Report (GWS-32) must be submitted to the Division of Water Resources to verify the well has been constructed and the pump has been installed.
